# Quarterly Bulletin:

### Real solutions from policy to payment

Welcome to the third quarterly National Diabetes Prevention Program (National DPP) Coverage Toolkit Bulletin of 2024. This bulletin is released every three months (in February, May, August, and November), and includes a synopsis of the new content that has been published on the National DPP Coverage Toolkit (the Toolkit) as well as key highlights that demonstrate the impact on its readership. Toolkit updates are developed in alignment with our partners' technical assistance needs, focusing on the information partners need to plan for, operationalize, and sustain payer coverage for the National DPP lifestyle change program.

Here is a summary of the Toolkit content updates and analytics from the past quarter, May – July 2024.

#### **Updated Content and New Features**

#### **New Toolkit Pages**

Three new pages were added to the Toolkit in this quarter:

- <u>Individuals with a Previous Gestational Diabetes Diagnosis</u>: This page provides guidance on how to effectively engage individuals with a previous gestational diabetes diagnosis in the National DPP lifestyle change program. Sections include a description of gestational diabetes, population-specific benefits of the program, and strategies and examples for engaging individuals with a previous gestational diabetes diagnosis in the program.
- <u>Engaging Community-Based Organizations</u>: This page features information on how community-based organizations (CBOs) can play a key role in scaling the National DPP lifestyle change program. Sections include types of CBOs, reasons to engage CBOs, examples of CBOs supporting the National DPP lifestyle change program, reimbursement for CBOs, and resources for engaging CBOs.
- <u>Community Care Hubs</u>: This page describes the functions of a community care hub (CCH) and the benefits of participating in one. Additional sections include how CCHs can offer evidence-based programs and address health-related social needs (HRSN), the difference between CCHs and other CBO network approaches, and spotlights on several CCHs.

#### **ICD Code Brief**

The <u>Internal Classification of Diseases (ICD) Code Brief</u> was updated to include information on ICD-11, which was released by the World Health Organization (WHO) in 2022. ICD-11 implementation will require a minimum of four to five years, and ICD-10 will be used until implementation is complete.



#### **164,006** Total Users Since Launch (6/22/17-7/26/24)




